Code 1906 In an action by a wife for a divorce, where there is sufficient evidence of cruel treatment extending-over several years, a divorce should not be denied plaintiff merely because, after she left defendant, she wrote him a friendly letter. *Forrester v. Forrester*, 101 Miss. 155, 57 So. 563. The common-law rule that an insane person could not contract marriage, and that such contract was void for want of assent and could therefore be annulled, has been changed by Code 1906, § 1669, par. 8, providing that insanity or idiocy at the time of the marriage is a ground for divorce, if the complaining party did not know of the infirmity. *Wilson v. Wilson*, 104 Miss. 347, 61 So. 453. To constitute "cruelty" within the divorce law, where there is no personal violence, the misconduct must be such as will impair the health or create a reasonable apprehension of bodily harm....
